- Conduct climate resilience assessments for our properties, and develop climate change adaptation and resilience solutions.

Employee

We treat employees as the foundation and future of the Group. We strive to promote diversity and equal opportunities, eliminate all forms of discrimination, protect labour rights, create safe and secure working environment, and provide staff with training and development opportunities on the following key aspects:

- Treat our employees fairly in every aspect of employment, training and career development, regardless of gender, sexual orientation, gender identity, age, physical and mental disability, family status, pregnancy, marital status, ethnic origin, race, religious belief and political affiliation;
- Develop high-performing teams through constantly updating and strengthening our

- Engage and communicate with our employees through diverse channels, and appreciate the collected feedback and suggestions.
